The DAA on review of its data presented to the JCPAA hearing on 14 February 2005, would like to advise a correction to the Committee. The total value of the combined DSAP and SDA overpayment of \$211,000 should have been \$242,625 making the average overpayment \$12,131. The figure of \$242,625 equates to 0.01% of all payment rights granted.

**Question 2:** Rather than guess work you would provide that later. This is in reference to Senator Hogg's question – How many were cancelled?

Answer: 205 cancellation decisions were undertaken.
