Response to Committee Questions during the Private Hearing on Audit Report No.15 2004-2005, the *Financial Management of Special Appropriations*

During the hearing, the Chair asked ANAO to provide the Committee with the number of Special Appropriations that are limited by amount. We have examined our audit data and have concluded that, at the time of the audit there were 131 Special Appropriations of limited amount out of a total of 414 Special Appropriations. Our analysis shows that, based on agencies' advice to the ANAO during the audit, 27 of the 131 limited Special Appropriations were available to be legally drawn. The remainder had expired or had been exhausted.

- Special Appropriations expire because of a time limit or sunset clause in the legislation, after which time they can no longer be legally drawn. For instance, 2003-04 was the last of the Category A years year in which the Special Appropriation at section 193(5) of the *Aboriginal and Torres Strait Islander Commission Act 1989* could be drawn to fund the Land Fund Special Account and the Indigenous Land Corporation.
- Special Appropriations are exhausted when they have been drawn to their full extent, after which no further drawings can legally occur. For instance, AusAID advised ANAO that it had fully drawn the limited Special Appropriation at section 4(1) of the Appropriation (East Timor) Act 1999-2000 to the amount of \$60 million. As the appropriation was now exhausted,

AusAID advised ANAO that it was seeking the agreement of its portfolio agency, Foreign Affairs and Trade, to repeal the appropriating clause.

During 2002-03, agencies reported a total of \$8,061 million drawn against limited Special Appropriations, itemised in the table at Attachment A. Of that total, \$7,236 million was assistance to State governments and hospitals under section 4(4) of the *Health Care (Appropriation Act)* 1998.
