DEAR SIRS.

IT IS THE SUBMISSION OF THIS EXECUTIVE THAT THIS TREATY NOT BE
RATIFIED. WE THE EXECUTIVE BELIEVE THAT CONVICTED PERSONS HELD
IN FOREIGN PRISONS RECEIVE NO LEGAL ASSISTANCE , ONCE THAT THEY
HAVE BEEN CONVICTED OF SERIOUS OFFENCES. WE DO NOT ACCEPT THE
IDEA THAT ANY PERSON DID NOT KNOW THAT THE PENALTIES INVOLVED
FOR CRIMES SUCH AS DRUGS , WEAPONS OR ANY ILLEGAL GOODS , ARE
SERIOUS AND THAT COULD RESULT IN A DEATH PENALTY BEING IMPOSED
THE EXECUTIVE BELIEVE THAT THIS IS INTERFERENCE IN THE LEGAL
SYSTEM OF ANOTHER NATION. WE DO NOT SUPPORT CRIMINALS WHO
HAVE NO REGARDS FOR LAW AND ORDER , HERE OR OVERSEAS.


IT HAS BECOME COMMONPLACE FOR PEOPLE TO CRY THAT THEY SHOULD
