## Departmental heads to discuss whistleblower protection laws Canberra – 27 November

The House Legal and Constitutional Affairs Committee will this Thursday hear from the Secretaries of the Attorney-General's Department, the Department of Immigration and Citizenship and a Deputy Secretary from the Department of the Prime Minister and Cabinet, on measures to support public servants who speak out about wrongdoing in the workplace. The hearing is part of the Committee's inquiry into whistleblowing protections within the Australian Government public sector.

There are a number of agencies within the Prime Minister and Cabinet portfolio that may investigate whistleblower type allegations including the Inspector-General of Intelligence and Security, the Commonwealth Ombudsman and the Privacy Commissioner. The Attorney-General's Department has responsibilities in key areas of whistleblower protection including Commonwealth secrecy policy, evidence law and Australia's international legal obligations. In its submission to the inquiry, the Attorney-General's Department noted that Australia is a signatory to two international treaties relevant to whistleblowers, the United Nations Convention Against Corruption and the Organisation for Economic Co-operation and Development Anti-Bribery Convention.

The Department of Immigration and Citizenship has recently undergone a major process of administrative reform following high profile investigations into a number of detention and deportation cases. The Department has also revised its own internal whistleblower procedures.

The Committee Chair, Mark Dreyfus QC MP said, "This hearing will provide an opportunity for the Committee to explore the administrative implications of implementing a new legislative framework on public interest disclosures".

"The Department of the Prime Minister and Cabinet and the Attorney-General's Department play critical roles in supporting the cross-portfolio integrity agenda of the Australian Government. The Department of Immigration has recently undergone a program of cultural change and governance reform. The discussion of the experience and responsibilities of these departments will assist the Committee in its consideration of new public interest disclosure laws" Mr Dreyfus said.
