DUTLES OF THE COMMUTTEE

Section 8 of the Public Accounts Committee Act 1951-1965 reads as follows :-

- 3. The duties of the Committee are -
 - (a) to examine the accounts of the receipts and expenditure of the Commonwealth and each statement and report transmitted to the Houses of Parliament by the Auditor-General in pursuance of subsection (1.) of section fifty-three of the Audit Act 1901-1950;
 - (b) to report to both Houses of the Parliament, with such comment as it thinks fit, any items or matters in those accounts, statements and reports, or any ofrcumstances connected with them, to which the Committee is of the opinion that the attention of the Parliament should be directed;
 - (c) to report to both Rouses of the Parliament any alteration which the Committee thinks desirable in the form of the public accounts or in the method of keeping them, or in the mede of receipt, centrel, issue or payment of public memorys; and
 - (d) to inquire into any question in connexion with the public accounts which is referred to it by either House of the Parliament, and to report to that House upon that question,

and include such other duties as are assigned to the Committee by Johnt Standing Orders approved by both Houses of the Parliament.

EIGHTY-NINTH REPORT

"The Sixth Committee"

INTRODUCTION

Your Committee has recognised the need for an analysis to be made of the type of inquiries conducted and reports submitted under its own programme and that of its predecessors. Whilst Indices have been prepared and issued as Reports periodically, these do not supply in any tabular or readily accessible form an analysis into categories of the work performed by Your Committee.

- 2. It will be highly desirable at an early date for every conclusion or finding appearing in Your Committee's Reports presented to the Parliament to be thoroughly indexed to guide the Public Accounts Committee, as this material is in the nature of "case law" and should be studied in the context of a current inquiry where similar principles may be involved.
- 3. Your Committee has decided that, as a helpful step in this direction, it should report to the Parliament in some detail on its own programme and related statistics for the Parliamentary period 1964-66. It has noted that, in recent years, many more requests for information relating to Your Committee's work have been received from Senators and Members, various organisations and students of political science or public administration. Some State Governments with a developing interest in the establishment of a Public Accounts Committee have also sought material for study.
- 4. This Report represents an effort to provide information and also, for the first time, to summarise the administrative position at the end of a Committee's programme.

COMMITTEE PERSONNEL

5. The Sixth Committee was appointed on 4/5th March, 1964.

- The death of the late Mr. John S. Cockle, M.P. robbed the Committee of a dedicated and able member. We have recorded our appreciation of his service and conveyed our sympathy to his widow and family.

- The First Public Meeting of the Sixth Committee was held in Camberra on 17th March, 1964, with the Observers, the Auditor-General's Office, the Department of the Treasury and the Public Service Board represented by the following officers:-

10. The Chairman (R. Cleaver M.P.), on behalf of the Committee, outlined the established procedures which would be followed and, in a general introductory statement, included the following points:-

"We believe that flexibility should be a significant feature of our work. The Sixth Committee will not adhere necessarily to the pattern and programme of previous Committees.

Regular investigation of the same items, of course, minimizes the value of any scrutiny. In our assessment, the field for investigation by the Public Accounts Committee is broad indeed and our authority most extensive. Our hearings and investigations in the years that may be ahead of us as a Committee will not be confined to Canberra,

We would hope that the Parliament may, from time to time, refer to us as a Committee, matters for attention as provided in Section 8(d) of the Act.

We feel that periodical reviews of departmental organisation and the methods used within the departments could be most profitable.

of course, widely inaccurate estimating has received the closest attention from preceding Committees. We would say that this is vital. Inaccurate estimating, either up or down, will always continue to attract the Committee's scrutiny but we are also cognisant of the inherent danger of panic spending in the last few months of the financial year just to clear an appropriation and to avoid criticism of a Committee like this.

The Public Accounts Committee really operates in the field of an efficiency audit which means that it asks departmental officers appearing before it very much more difficult questions than it would have if it confined itself solely to the accounts and votes of the departments. It means it cannot and does not accept a yes-no answer, and also expects as a Committee to be informed if its deductions are incorrect.

The most effective check on administration is to have an outsider looking in. The Public Accounts Committee is just that. It is an outsider; an outside representative of the community at large that looks in on an organisation created by the Government to promote the community's welfare. The Committee is part of the governmental machinery of the country, yet it is responsible not to Ministers but to electors. So it acknowledges no ministerial head. Properly, too, it represents that part of government whose function it is to criticise,"

PROGRAMME 1964-1966

- Consistent with the announced policy, Your Committee conducted Public Inquiries in Darwin, Perth, Adelaide, Melbourne, Sydney and Canberra.
- 12. The tables set out below present firstly the statistics relating to Your Committee and secondly an analysis of the type of reports presented to the Parliament and the aggregate of all reports presented to this date.

Your Committee has used its term of office to influence a broad cross section of the entire Public Service. Attention is drawn to the fact that a developing Nation has brought about a sophistication in the Public Service and the depth of technological and scientific research employed has broadened the extent of Departments. Today the Commonwealth has 25 major Departments and, in addition, approximately 115 Eureaux, Sections or Statutory Authorities which are subject to report by the Auditor-General and the interest of Your Committee.

13. From this it is clearly apparent that the scope for increased Committee activity is substantial and the only limiting factors are the general Parliamentary programme and the allocation of additional time for the duties of Your Committee by the elected Members.

FOLLOW UP PROCEDURE

- 14. The system established in 1953 of receiving through the Commonwealth Treasurer, a Treasury Minute relating to each Report has been retained. This provides for the Department of the Treasury to co-ordinate all possible action to implement the findings and recommendations embodied in the Reports.
- 15. Over the years this arrangement has proved to be a most effective system. After examination each Minute is submitted in Report form to the Parliament, thus completing the full circle of investigation report and action.
- 16. Your Committee has appreciated the co-operation extended at all times by the Department of the Treasury with which arrangements were entered into in 1964 for a special half yearly report on outstanding Treasury Minutes. The present position is that Treasury Minutes have yet to issue in respect to the following Committee Reports:-

With reference to those Minutes longest outstanding, Your Committee is satisfied, after discussions with the officers of the Department of the Treasury, that matters of principle with wide ramifications are involved. For this reason, the issue of such Treasury Minutes has, of necessity, been delayed.

PUBLIC ACCOUNTS COMMITTEES - AUSTRALIA & OVERSEAS

- 17. We have established helpful contacts with Public Accounts Committees operating in the States. Prior to the establishment of the Public Accounts Committee of Papua and New Guinea in 1965 we were pleased to extend assistance to the Chairman and staff from the Territory. We have noted with interest the first reports issued by that Committee.
- 18. Stemming from an overseas trip by the Chairman in 1964, valuable links have been established with Public Accounts or Finance Committees in South Africa, Rhodesia, Kenya, Israel, Britain, Canada, the United States of America, Jamaica, Trinidad and Tobago, Guyana, New Zealand and Malaysia. An exchange of Committee programmes and official reports has been arranged.
- 19. Your Committee has made some appreciable progress in building up adequate working facilities on all levels of operation and believes that an authorative reference library on Public Accounts Committees and related matters on Public Administration should be developed. It believes that an assessment should be made of the terms of reference, work programmes and type of reports of overseas Committees to establish improvements which may be adopted to the advantage of the Parliament.

PUBLIC INQUIRY PROCEDURES

- 20. To assist witnesses appearing before Your Committee, our Public Inquiry procedures have been refined. Notes relating to evidence are issued to all Departments appearing before the Committee to enable preparation to be made with confidence.
- 21. Notes for general observers from the public have also been made available and Your Committee has found that the many Commercial and Taxpayer Associations, Accountancy Institutes and similar bodies quite apart from public servants have readily accepted invitations to attend Public Inquiries in the various capital cities.
- 22. Your Committee invariably meets for final consultation and review of exhibits in a Pre-Inquiry session which has proved its value.

FACILITIES

23. In 1965 improved office accommodation for Your Committee and its staff was made available by the Presiding Officers.
Your Committee has offices, with a Committee Room appropriate for domestic meetings and discussions with Departmental officials adjoining the suite. Public Inquiries call for Committee Rooms even larger and more suitably arranged than the existing and modern accommodation now provided on the House of Representatives side of the building. When the new Parliament House is designed, these problems should be taken into account as interest in the work of Your Committee, on occasions, necessitates extensive seating.

OBSERVER ASSISTANCE TO YOUR COMMITTEE

24. The expansion of Your Committee's programme during this Parliamentary Session has made heavy demands on the services traditionally provided by the Observers - the Auditor-General, the Public Service Board and the Department of the Treasury. Your Committee would pay a sincere tribute to the helpful advice and guidance provided by the Observers whose assistance is indispensable to the conduct of effective public inquiries by Your Committee.

STAFF

- 25. The research, preparation, servicing of Your Committee, conduct of Fublic Inquiries and assistance with Reports has represented a heavy and constant demand upon the Committee's staff. The Executive Secretary, Mr. David N. Reid, Project Officers, Mr. K. W. Wood and Miss I. Fleming and the administrative staff have given splendid service.
- 26. Research work for a Committee of this nature is essential and the present staff is inadequate to cope with programmes reasonably designed to make an impact upon the Public Service and also to influence a good proportion of the Items in the Annual Estimates of the Parliament.

27. In many of our reports we have recognised that staffing problems have impeded departments in the efficient prosecution of their functions. As Your Committee recognises that the efficient operation of its own duties can also be materially impeded by inadequate staffing, it trusts that the authorities concerned will give proper and ready consideration to any staff expansion proposals which may be recommended on its behalf.

CURRENT WORK

- 28. All evidence taken in Public Inquiry has resulted in the submission of Reports to the Parliament. Likewise no Treasury Minute remains on hand at this date.
- 29. Exhibits from certain Departments relating to their entry into Automatic Data Processing are on hand for public evidence to be sought if desired by our successor Committee. It was the intention of Your Sixth Committee, had the time table been adequate, to have submitted further reports on A.D.P. networks within the Commonwealth Public Service, believing that these would be complimentary to our Eighty-Fifth and Eighty-Sixth Reports.
- 30. The 1966 Supplementary Report of the Auditor-General, not having been available to Your Committee, may represent a probable field for later inquiry.
- 31. Arising from its experience, Your Committee believes that the work which it undertakes on the basis of free discussion and open inquiry, represents a vital contribution to the effective operation of responsible Parliamentary Government.
