PARLIAMENTARY STANDING COMMITTEE ON PUBLIC WORKS

THIRTIETH GENERAL REPORT

To His Excellency the Right Honourable Lord Casey, P.C., C.H., D.S.C., M.C., K.St.J.,

Governor-General in and over the Commonwealth of Australia.

May It Please Your Excellency:

In pursuance of the requirements of Section 11 of the Public Works Committee Act 1913-1966, the Purliementary Standing Committee on Public Works have the honour to submit the following report on their proceedings during the First Session of the Twenty-sixth Parliament.

TWENTIETH COMMITTEE

- 1. Members of the Twentieth Committee were appointed in the Sonate and in the House of Representatives on 22 February 1967. They were Senator G.H. Branson, Senator F. Dittmer, Senator E.W. Prowse, Messrs. L.L. Bosman, F.C. Chaney, W.J. Fulton, R. McN. Holten, A.W. James and W.P. O'Connor.
- 2. At the first meeting of the Committee on 23 February 1967, Mr. F.C. Chaney was elected as Chairman and Mr. W.P. O'Connor as Vice-Chairman.

PROPOSALS REFERRED TO THE COMMITTEE

3. Sixteen proposals were referred to the Committee during the period covered by this report. Inquiries on fifteen have been completed or are approaching finality and reports on eleven have been presented to Parliament.

4. The eleven proposals on which reports have been presented and the estimated cost of each when referred to the Committee are:

5. Inquiries on the four following works are nearing completion and it is expected that reports on each will be tabled early in the next Session. The estimated cost of these works when referred to the Committee is indicated.

- 6. Although the proposal to redovolop the Royal Australian Navy's base at Manus Island in the Territory of Papua and New Guinea was referred to the Committee in May 1967 and the site inspection was carried out shortly afterwards, inquiries have not yet been completed. This is due to the changes that have occurred in the redovelopment proposals and to the resulting delays that have occurred in the presentation of departmental submissions.
- 7. A tabulated summary of the references is attached.

MEETINGS

6. The Committee hold 47 mootings during 1967 and two in 1968 to the date of this report. The taking of evidence and inspections involved visits to Sydney, Darwin, the Western Barkly Tablelands area of the Northern Territory, Manus Island, Port Moresby, Perth, Lismore, Mackay, Rockhampton, Novra, Adelaide and Brisbane. A considerable number of public hearings and meetings was also held in Camberra.

SCOPE OF WORKS TO BE REVIEWED

- 9. In paragraphs 20 to 22 of the Twenty-ninth General Report, reference was made to an opinion of the Attorney-General stating that, in his view, the Public Works Committee Act did not preclude from Committee scrutiny works for the Commonwealth outside the geographical boundaries of the Commonwealth.
- 10. Consequent upon this opinion, the proposal to develop the facilities at the Royal Australian Navy's base at Manus Island was referred to the Committee in May 1967 for investigation and report to Parliament. This is the first instance of a proposed work outside the Commonwealth being referred to the Committee.

DEPARTMENT OF CIVIL AVIATION REFERENCES

- 11. In paragraph 16 of the last General Report, the Ninetcenth

 Committee drew attention to the hasty planning which appeared to precede
 the presentation of the Mascot and Tullamarine Airports references to the

 Committee in 1965. Comments were made that "... the preparation of
 designs often appeared to have been rushed with the result that some basic
 planning decisions had not been taken" and that "... there could have
 been a better understanding of the works in the Departments concerned had
 planning of the projects been approached less hurriedly".
- 12. The following table compares the estimated cost of the current works at Mascot and Tullamarine whon referred to the Committee, with the estimates most recently accepted by the Government.

In addition, approval has been given for a \$2 million contingency for Mascot and \$1.5 million for Tullamarine for design detailing and unforeseen variations.

13. The Committee have no charter to reopen an inquiry into a reference once tenders have been accepted but we believe we have a duty to express our grave concern at the wide disparity between the original and current estimates for these works, particularly for the terminal buildings. It is apparent from the information we have that where dramatic increases have occurred they are generally a consequence of hurried or faulty planning. In one instance it is relevant to note that the cost of part of the work was omitted from the estimate given the Committee.

14. The Committee believe that the history of these projects emphasises the need for care by Departments when contemplating the expenditure of public funds on major works and for more thorough consideration of detail in the preliminary stages of design.

REVIEW OF PUBLIC WORKS COMMITTEE ACT AND REGULATIONS

15. The Committee understand that the Government has now completed the review of the Public Works Committee Act and Regulations mentioned in the previous General Report and that emending legislation will be introduced shortly.

APPRECIATION

- 16. To the many departmental and private witnesses who gave evidence at the public hearings and to those who assisted at site inspections and in other ways, the Committee express their gratitude.
- 17. We are also most appreciative of the co-operation and services provided by the Principal Parliamentary Reporter and his staff.
