JOINT COMMITTEE ON PRICES

The Committee was appointed by resolution of the Senate and the House of Representatives on 12 April 1973 to inquire into and, as appropriate, report upon:

- (a) complaints arising from prices charged by private industry and by the public sector;
- (b) movements in prices of goods and services in particular fields or sections of private industry and the public sector, for example, as measured by price indices; and
- (c) such other matters relating to prices as may be referred to the Committee by resolution of either House of the Parliament.

On 10 May 1973 the Committee resolved that two sub-committees be formed to be known as Sub-committee 'A' and Sub-committee 'B'.

The Committee resolved on 18 September 1973 that it inquire into prices charged in Australia for meatmeal and on 20 September 1973 that the Inquiry be conducted by Sub-committee 'B'.

RECOMMENDATIONS

The Committee recommends that:

- (i) the practice of some meatmeal manufacturers consulting on the establishment of list prices for the industry be brought to the attention of the Commissioner of Trade Practices by the Attorney-General with a view to investigation under the Restrictive Trade Practices Act; (paragraph 35)
- (ii) the power of the Australian Government to regulate the export of meatmeal under the Customs (Prohibited Exports) Regulations should be applied more stringently not only to ensure that the domestic market has priority in the use of available supplies but also as a means of reducing and stabilising the price of meatmeal. (paragraph 36)

REPORT ON THE PRICE OF MEATMEAL

1. Introduction

Background

The Joint Committee on Prices has received many complaints concerning the rapid increase in the price of meatmeal. The complaints were mainly from users of meatmeal and were substantiated by evidence presented at public hearings of Sub-committee 'B' in its conduct of the Inquiry into the Stabilisation of Meat Prices. The Committee found in that Inquiry that shortages of and high prices for grains and protein meal were factors adversely affecting expansion of the white meat industry, and recommended that supplies of stock feed be assured to the industry.

Terms of Reference

2. Pursuant to Clause (a) of its Terms of Reference the Committee resolved on 18 September 1973 to inquire into the price of meatmeal.

Public Hearings

3. Public hearings were held in Canberra on 30 and 31 October 1973. Five organisations gave evidence and Appendix 1 shows the list of witnesses who gave evidence and the list of other organisations whose submissions were incorporated in the transcript of evidence.

4. Evidence given at the public hearings is available in Hansard form for purchase from Australian Government Publishing Service bookshops and is available for inspection at the Committee Office of the House of Representatives and at the National Library.

2. Main Features of the Industry

5. Meatmeal, together with other protein meals, is used as a supplement in stock food to increase the nutritional value of that food. It is a particularly important input to the intensive animal industry comprising pigmeat and poultry meat, eggs and, to a lesser extent, red meat, milk and butter. Appendix 2 shows the estimated supply and demand position of protein meals in 1971-72 and 1972-73.

6. Meatmeal and tallow are joint by-products of the meat industry. Offals, butchers' shop waste and condemned carcasses are ground and cooked, and from this process meatmeal and tallow are produced.

7. Establishments producing meatmeal are of two types, namely meatworks, which operate rendering establishments and rendering works which function independently of meatworks.

8. Meatworks with rendering establishments derive raw materials from the slaughter floor in the form of inedible offals and condemned carcasses. Non-abattoir rendering works purchase raw materials from retail butcher shops, boning rooms and, to a lesser extent, from small meatworks without rendering facilities.

9. The evidence indicated there were difficulties in establishing the cost of production of meatmeal. The Metropolitan Meat Industry Board, which operates an abattoir at Homebush in Sydney stated that it did have a costing of its by-products division. Even if costs of production were obtained for individual manufacturers, comparisons of costs would be difficult because of the differences in age of the plants, the processes employed and cost of raw materials.

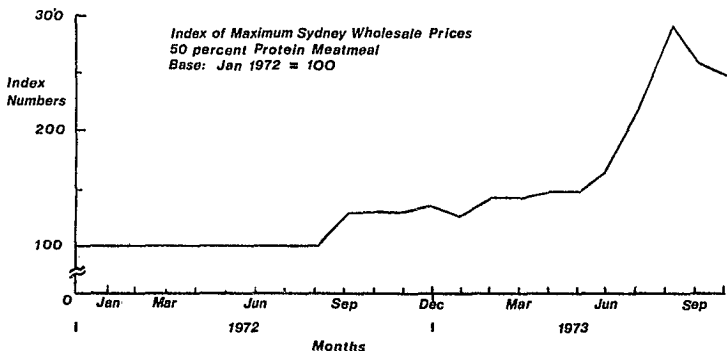
10. Meatworks with rendering facilities make no payment for raw inedible offals from their slaughtering sections but revenue obtained from the sale of by-products is taken into account when slaughtering fees are determined. Non-abattoir rendering works have indicated that prices paid for shop waste vary in line with prices received for the processed products. Prices paid for shop waste in the Sydney Metropolitan area increased from 0.64 cents per pound to 2.732 cents per pound for bones between November 1972 and September 1973 and, in the same period, the price of fat increased from 2.48 cents per pound to 6.618 cents per pound.

3. Meatmeal Prices

Variations in Prices

11. There are variations in prices quoted for meatmeal, both on the domestic and overseas markets. These variations are attributable to the location of plants, variability of the product and commercial marketing practices. For example, the public abattoirs generally quote prices that are lower than those quoted by private enterprise.

12. Wholesale prices quoted in Sydney for 50 per cent crude protein meatmeal are indicative of prices elsewhere in Australia and are shown in Appendix 3. It can be seen that prices remained relatively stable from January to September 1972, then increased from \$92 to a peak of \$268 per short ton in August 1973, a yearly increase of \$176 per short ton or 190 per cent. In September and October 1973 prices on the world market eased following the lifting of restrictions on exports of protein feed-stuffs by the United States of America (U.S.A.) and the prospects of record crops of soya beans. This led to a fall in domestic prices of \$42 per ton.

Reasons for Price Increases

13. The Committee finds that the dramatic increase in domestic prices for meatmeal is predominantly due to the shortage of protein meal on the world market, particularly fish meal and soya bean meal.
14. The failure of the Peruvian anchovy catch in the 1972-73 season was the most significant factor influencing the market. The shortage was further accentuated by embargoes on the export of cereals and oil seeds by Canada and the U.S.A.
15. As a result of these shortages Japan greatly increased its purchases of Australian meatmeal.
16. The domestic prices for meatmeal followed escalating world prices. However, domestic prices were generally below those ruling on the world market. Over many years the export price has been the basis of negotiation for local prices.
17. Sub-committee 'B' was told that meatmeal manufacturers' selling prices are fairly similar. Some manufacturers get together and establish list prices for the succeeding month by averaging their prices of the previous month. Other evidence was of speculation and of withholding supplies. Evidence presented by stock feed manufacturers and representatives of the pigmeat and poultry industries demonstrated that at times and in certain locations it was difficult to obtain supplies. The manufacturers of meatmeal said that at times it was difficult to meet demand.
18. These factors and overseas buying not only contributed to increases in meatmeal prices but also caused a reduction in apparent local sales of protein meals. Thus, while exports increased by 52,000 tonnes or 62 per cent

between 1971-72 and 1972-73, local sales of protein meal fell by 39,000 tonnes or 8.5 per cent. The apparent local sales of meatmeal fell by 10,000 tonnes in the same period. Further details are provided in Appendix 2.

19. Following the lifting of export restrictions by the U.S.A. on 1 October 1973, mainly as a result of record soya bean crops, the Japanese have substantially withdrawn from the Australian market for meatmeal. World prices for meatmeal have declined accordingly and this decline has been reflected in domestic prices.

Effect of Increases in Price on Users and Consumers

20. Stock feed comprises 70 to 80 per cent of total costs for both poultry meat and pigmeat. Meatmeal as a proportion of the cost of stock feed varies from 8 to 12 per cent for poultry meat and 15 to 20 per cent for pigmeat. For every \$100 per ton variation in the price of meatmeal, the cost of production varies by about 3 cents per dozen for eggs, 3 cents per pound for pigmeat and by about 1.7 cents per pound for poultry meat. As the maximum price increase of meatmeal was \$176 per ton over the last 12 months, this means a cost of production increase of 5.3 cents per dozen for eggs, 5.3 cents per pound for pigmeat and about 3 cents per pound for poultry meat.

21. The cost of production arising from increased prices of meatmeal is only one factor influencing the price paid by the consumer. Other factors are supply and demand and the percentage mark-up of wholesalers and retailers. Figures published by the Bureau of Census and Statistics show that in Sydney the retail price of 60 gram eggs increased by 16 cents per dozen between September 1972 and September 1973. Over the same period the retail price of pork chops increased by about 13 cents per pound and the price of frozen chickens by about 18 per cent.

22. It can thus be seen that an important factor in the increase in the price of eggs, poultry meat and pigmeat was the increase in the price of meatmeal.

Outlook

23. Factors likely to influence the price of meatmeal are the current shortage of fish meal on the world market, increases in the supply of soya bean meal and grains suitable for stock feed, particularly from the U.S.A., and a further decrease in Japanese buying of Australian meatmeal as protein meals and grains from other sources become available.

24. It is expected that demand in Australia for protein meals will increase and this will be balanced by increased production of meatmeal as more livestock become available for slaughter and sowings of soya beans and other oil seeds are increased.

25. The Committee notes that the price of meatmeal has recently fallen. Some witnesses said that the price of meatmeal would stabilise at about the present level whilst others said that price would continue to fall. However, the Committee considers that the price is unlikely to decrease to the levels of 1972.

4. Australian Government Controls

26. The constitutional authority for direct control of prices rests with the State Governments.

Customs (Prohibited Exports) Regulations

27. The Australian Government, however, has the power to control exports of protein meals under the Third Schedule of the Customs (Prohibited Exports) Regulations. Protein meal may not be exported without the approval of the Department of Primary Industry. In exercising this control the Department uses several criteria including:

- . the priority for the domestic market in the use of available supplies;
- . the distance of some meatmeal producers from the points of domestic consumption;
- . difficulties associated with the storage of surplus production; and
- . the desirability of preserving established overseas markets by providing some continuity in supply.

28. The Department administers this control in consultation with the State Departments of Agriculture as well as the meatmeal and stock feed industries. Assessments of local requirements and availability are made on the basis of information submitted on the level of stocks, production and sales estimates by the industry. In most States quotas are issued to meatmeal manufacturers. These quotas relate to the maximum quantity of meatmeal the Department will approve for export by each firm in the month concerned. The documentation required by the Collector of Customs (Restricted Goods Export Permit) is issued by the Regional Offices of the Department in each State.

29. As a result of a world shortage of protein meals the Department intensified its supervision of all exports of protein meals in 1973. The Department claims that the restrictions are proving effective.

Prices Justification Act 1973

30. Some meatmeal manufacturers come within the jurisdiction of the Act because their annual turnover exceeds \$20 million. The Tribunal has exempted these companies from notifying it of proposed price increases if certain conditions apply. These conditions are where the meatmeal is sold by auction, where prices are fixed by contracts entered into following the submission of competitive tenders or competitive quotations, or where increases in price are due entirely to and accurately reflect the amount of an increase in the cost of raw materials.

31. Similarly, exemptions have been granted to stock feed manufacturers where increases in the price of prepared stock feed are due entirely to and accurately reflect the amount of an increase in the cost of raw materials used in manufacture.

5. Findings and Recommendations

32. The main cause of the increase in the price of meatmeal in Australia was the rapid increase in export prices in the last 12 months because of world shortages.

33. The Committee finds that the extent of the increase in domestic prices, however, has been influenced by a practice which has resulted in prices being higher than those established under more competitive conditions. This practice is that of some meatmeal manufacturers consulting on the establishment of list prices for the industry. The Committee therefore recommends that this matter be brought to the attention of the Commissioner of Trade Practices by the Attorney-General with a view to investigation under the Restrictive Trade Practices Act.

34. The Committee also finds that the increase in the price of meatmeal has contributed to higher prices paid by consumers for eggs, poultry meat and pigmeat. Evidence presented during the Inquiry confirms the Committee's findings in its report on the Stabilisation of Meat Prices that there is a need for assured supplies of stock feed to the white meat industry.

35. The Australian Government has the power under the Customs (Prohibited Export) Regulations to regulate the export of meatmeal and a policy criterion under which the Department of Primary Industry operates is that the domestic market has priority in the use of available supplies. The Committee notes, however, that the regulations have not been used as a means of controlling prices.

36. The Committee therefore recommends that the power of the Australian Government to regulate the export of meatmeal under the Customs (Prohibited Export) Regulations should be

applied more stringently not only to ensure that the domestic market has priority in the use of available supplies but also as a means of reducing and stabilising the price of meatmeal. The Committee suggests that the administering authority use the year 1971-72 as a base for establishing the requirements of the domestic market. The authority should take into consideration the growth of the intensive animal industry and its need for other protein meals.
