

HOUSE OF REPRESENTATIVES

STANDING COMMITTEE ON ABORIGINAL AFFAIRS

1. On 1 December 1976^1 and again, following prorogation of the Parliament, on 10 March 1977^2 , the following resolution was passed by the House of Representatives:

- (1) That the following matter be referred to the Standing Committee on Aboriginal Affairs:
 - The health problems of Aboriginals with particular attention to:
 - (a) the prevalence of different types of disease suffered by Aboriginals and Aboriginal communities;
 - (b) the relationship between Aboriginal health and environmental, social and cultural factors;
 - (c) the effectiveness of existing health care programs for Aboriginals generally, and the adequacy of Western European-type health services to cope with the health problems of Aboriginals, and
 - (d) alternative methods of health care delivery that take account of Aboriginals' life styles, including camp situations.
- (2) That the Committee consider ways and means by which:
 - (a) persons with appropriate qualifications can be encouraged to assist Aboriginals achieve a better standard of health; and
 - (b) Aboriginals including traditional healers can participate in the development and delivery of health care services to their own communities, and in any modification of existing services.

(3) That the committee recommend possible courses of action.

2. The Inquiry has just begun in detail. It was not possible to commence it in earnest earlier because:

- (a) The Committee had to complete its Inquiry into the Alcohol Problems of Aboriginals. This Report was tabled in the House today.
- (b) Members of the Committee were ex officio members of the Joint Select Committee on Aboriginal Land Rights in the Northern Territory. This Committee was first formed on 9 December 1976³ and was required to report to the Parliament by 18 August 1977.⁴

3. The Health of Aboriginals Inquiry was advertised in the capital city press and interested persons and organisations were requested to present submissions. The first public hearings were held in Canberra on 21 October 1977.

- . In view of the importance of the Inquiry it is recommended that:
 - (a) the Committee be reconstituted by the new House of Representatives;
 - (b) the reference referred to in paragraph 1 be given to the reconstituted Committee by the new House, and
 - (c) the reconstituted Committee be empowered to consider and make use of the records of the present Committee.
