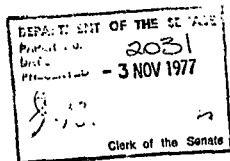

JOINT STANDING COMMITTEE

Extracts from the Resolution of Appointment

Paragraph (1)

That a Joint Standing Committee be appointed to act for and represent the Parliament, as the client for the new and permanent Parliament House, in all matters concerned with the planning, design and construction of the new and permanent Parliament House and all matters incidental thereto.

Paragraph (2)

That the committee reconsider and, as necessary, amend the recommendations of the former Joint Select Committee on the New and Permanent Parliament House contained in its report dated March 1970, which when revised shall be used as the basis of the construction of the new and permanent Parliament House.

Paragraph (17)

That the committee be authorised to provide, on behalf of the Parliament, all necessary information concerning the functional requirements for the new and permanent Parliament House and matters incidental thereto direct to the National Capital Development Commission as the Authority responsible to Parliament to undertake or arrange for the planning, design and construction of the new and permanent Parliament House.

COMMITTEE REPORT

1. In its First Report⁽¹⁾, presented to Parliament on 3 May 1977, the committee concluded that construction and occupation of stage I of the new and permanent Parliament House by 26 January 1988 is both feasible and practical. The committee agreed to a timetable which would enable completion of the first stage by that date - the 200th anniversary of European settlement in Australia.
2. As indicated in the report it has been necessary for the committee to review in detail the 1970 recommendations of the Joint Select Committee on the proposed new and permanent Parliament House⁽²⁾ as well as examine the estimates of accommodation requirements and the functional relationships necessary for the new building.
3. The committee is currently considering a draft design brief for the new and permanent Parliament House. The purpose of the brief is to document the requirements of all users of the Parliament in such a way that the needs and methods of operation are described and illustrated in sufficient detail to allow those who will be involved in the design and construction processes to understand what is required. When completed the brief will set forth the scope, functions and physical requirements for the building, associated facilities and site development, and propose a program for further work leading to the construction of the new Parliament House.
4. To this brief will be added technical information on mechanical, electrical and communications facilities and other matters such as acoustics and security to form the complete architectural brief. Because of the size, complexity and importance of the proposed new Parliament building, the material supplied to the designer, particularly the sections on user requirements and functional relationships, must be detailed and comprehensive if the design is to satisfy the differing demands which will be placed on the building. This has resulted in the preparation of a large and intricate document with information in ranging degrees of detail.
5. The committee has made substantial progress in considering the draft design brief but will be unable to complete its work prior to the dissolution of the House of Representatives. As preparation of this brief is an important step in the timetable previously adopted, the committee has requested officers of the Parliament and the National Capital Development Commission to undertake a detailed review of the brief and proceed with preparation of certain technical information necessary for the final architectural brief.

6. The committee re-affirms the need for an early commencement on construction of the new and permanent Parliament House. It therefore recommends that a committee with similar terms of reference be appointed without delay in the Thirty-first Parliament and that such committee have power to consider and make use of the evidence and records of the present committee.
7. Progress towards completion of the architectural brief will be interrupted by the dissolution of the House of Representatives. Nevertheless, the committee re-iterates that it remains feasible and practical to achieve occupation of the first stage of a new building by 26 January 1988.

MR PRESIDENT:

I present the second report of the Joint Standing Committee on the New and Permanent Parliament House, together with minutes of the proceedings.

The committee's first report, which was presented on 3 May 1977, indicated that the committee had agreed to a program which would enable a fully functioning, stage I, parliament house to be constructed and occupied by 26 January 1988 - the 200th anniversary of European settlement in Australia.

The purpose of this second report is to inform Parliament of the progress which the committee has made in preparing a design brief for the new parliament house. The report also recommends that a similar committee be appointed early in the life of the next Parliament so that the program of work leading to construction of a new building will not be delayed.

The committee re-iterates that it remains feasible and practical to achieve occupation of the first stage of a new building by 26 January 1988.
