

## **REPORT FROM THE HOUSE OF REPRESENTATIVES**

## SELECT COMMITTEE ON TOURISM

1. On 1 December 1976, the Committee was appointed by Resolution of the House of Representatives to:

- (a) examine the significance and potential of tourism in the Australian economy and whether it has special features in comparison with other industries, with particular reference to its effects on:
  - (i) employment,
  - (ii) balance of payments aspects,
  - (iii) the community's knowledge of Australia and the Australian heritage,
  - (iv) community health and welfare, and
  - (v) regional development and decentralisation;
- (b) identify the short and long term issues facing the industry in Australia;
- (c) examine the importance of the various modes of transport in the development of tourism to and within Australia;
- (d) examine the roles and responsibilities of the Commonwealth, State and local governments and the industry in relation to the development and promotion of tourism;
- (e) assess the adequacy and the availability of statistical and other information relating to tourism, and
- (f) report on its investigations into these matters and to recommend action that might be taken by the Commonwealth Government or by the Commonwealth Government in co-operation with State and local governments and the tourist industry to alleviate any problems identified by the Committee during the course of its investigations.

2. The Committee held its first meeting on 8 December 1976 and since then has met on five occasions which were for public hearings. The Committee has heard evidence from 32 persons representing 15 organisations, taken almost 1300 pages of evidence and received many exhibits. The Committee has also conducted four inspections.

3. The Committee has received submissions from 93 organisations and a further 28 organisations have indicated their intention of making a submission to the Committee.

4. The submissions received so far cover a wide range of issues and the problems facing the tourism industry are many and varied. Before any considered recommendations can be made it will be necessary for the Committee to conduct an extensive probing inquiry.

5. It is recommended that the Committee be reconstituted after the prorogation of the Parliament. It is further recommended that the Parliament give the new Committee power to consider and make use of the records of the present Committee. 6. It is further recommended that the Parliament give the new Committee power to bring up an interim report. The present Committee is empowered to report as soon as possible. The Committee considers there are certain issues on which it may wish to make recommendations before it has completed its final report. Accordingly it has recommended that the new Committee be given the power to report from time to time.
