Productivity Commission Chairman and Chief Scientist to appear at inquiry into business commitment to R&D

The **Chief Scientist**, Dr Robin Batterham, and the Chairman of the **Productivity Commission**, Mr Gary Banks, will be among those appearing this Monday at a hearing of the House of Representatives Science and Innovation Committee's inquiry into business commitment to research and development (R&D) in Australia.

The inquiry is looking at the economic benefits for Australia of a greater private sector investment in R&D, the impediments to business investment in R&D, and the steps that need to be taken to better demonstrate to business the benefits of higher private sector investment in R&D.

The **Chief Scientist** is the Executive Officer of the Prime Minister's Science, Engineering and Innovation Council, and a member of the Commonwealth-State Innovation Advisory Council and the Cooperative Research Centres' Committee. Dr Batterham, who was appointed to the position in May 1999, is taking a lead role in establishing national research priorities and promoting linkages between science, industry and government.

The **Productivity Commission** is the Commonwealth's principal review and advisory body on microeconomic policy and regulation. The Commission has published numerous studies on the impact of business assistance programs.

The Committee will also be hearing from the **Industry**, **Research and Development Board**, which administers the Commonwealth's R&D support programs. In 2002-03, the Board will administer programs providing a total of \$682.4 million in assistance to some 5,250 Australian businesses. Others scheduled to give evidence include the **Australian Information Industry Association**, the peak body representing suppliers of ICT goods and services, and **Agriculture**, **Fisheries and Forestry – Australia** (AFFA). AFFA oversees the operation of the rural Research and Development Corporations.
