LEVIES ON REVENUE in Australia of Listed and foreign companies and Family tontine trusts ; [Total revenue in Australia = \$2.1 trillion, about \$1.5t by Listed and foreign companies and Family tontine trusts in Australia.]

- .02 for technology fund. As managed by Private Company For Technology Fund paid 5%. [.02 x 1.5t = \$30,000,000,000. \$4.2b in 02]
- .01 for warranty and insurance for goods and services sold in Australia. [.01 x 1.5t = \$15,000,000,000.]
- .0025 for patents. As managed by Private Company For Patents Registry paid 10%. [.01 x 1.5t = \$3,750,000,000]
- .0025 for audit reports as commissioned from an auditor approved and appointed by the Private Company For Audit Reports Commission. [.0025 x 1.5t = \$3,750,000,000]
- .001 for knowledge prizes as managed by Private Company For Knowledge Prizes paid 1%. Each recipient paid GDP x .000002 = \$1,000,000. [.001 x 1.5t = \$1,500,000,000.] [1,500 prize recipients each year.]

- .02 levy on revenue in Australia for technology fund. As managed by Private Company For Technology Fund paid 5% of revenue. [.02 x 1.5t = \$30,000,000,000.]
- *Patents ; .0025 levy on revenue in Australia for patents. As managed by Private Company For Patents Registry paid 5% of revenue. [.01 x 1.5t = \$3,750,000,000]
